Summary of Terms and Conditions of Licence (see Licence for all):

- 1. Term is for one year, with a one year right of renewal, being a maximum of two year term in total.
- 2. On the expiry of the licence, termination due to breach of conditions, or surrendering by the licensee, Expressions of Interest will be called for.
- 3. Public liability insurance to be retained during the term of the licence for the purpose of indemnifying Council to a minimum limit of \$20million, or as reviewed from time to time.
- 4. Licensee to pay for all water used during the term of the licence.
- 5. Grazing activity to cease during times of un-seasonal conditions (eg drought), and/or as directed by Council.
- 6. Licensee to maintain all fixtures and fencing on the land in good repair.

Fees:

Annual licence fee to be calculated as follows:

- a) Administration fee, plus
- b) Grazing fee (calculated at rate per hectare)

The administration and grazing fees are applicable if the Lessee is an individual or trading entity, and the grazing activity is identified for income generating purposes.

If the Lessee is an incorporated community group or organization which uses the grazing licence for the purpose of raising funds for the group's activities, the administration fee applies, and the grazing fee is exempted.

If the grazing activity undertaken by an individual is for the keeping of horses for personal recreational activities, the administration fee applies, and the grazing fee is exempted.


